## Pro-Choice Groups - Comparison

Canada has about 16 active pro-choice groups, and an estimated 100 sexual and reproductive health centres/clinics. (This does not include abortion clinics and hospitals that provide abortions; see below):

- 100 clinics/agencies (estimated) that focus on providing sexual and reproductive health care or info:
  - o BC alone has about 48 clinics operated by Options for Sexual Health, which is a charity.
  - All 4 Planned Parenthood clinics are charities.
  - Charity status of remainder not all checked, but it appears a minority are charities.

## Accredited healthcare facilities that provide abortions: (not comparable to anti-choice agencies)

- 29 standalone clinics (5 are charities)
- 13 hospital-based women's clinics (11 are charities)
- About **80-90** additional hospitals, including CLSCs in Quebec (Most are charities)

The above does not include primary care clinics, doctors' offices, and sexual health centres that offer medical abortion.
